

The NYS Horse Council serves as the umbrella organization that unites New York's diverse horse community into one unified voice to promote and protect the interests of New York State's horse industry.

What Does the NYSHC Do?

We partner with The American Horse Council, The Coalition of State Horse Councils and the Empire State Council of Agricultural Organizations, Inc. to monitor and advocate for legislation that supports the concerns of New York agriculture and livestock. Out of all the legislators in Albany, only a handful have experience in farming, and fewer still own or have experience with horses. We believe it is important that our voice be heard when laws are being proposed that will impact agriculture, and specifically horses.

Our Successes Include

- Horse boarding declared an agricultural pursuit, which facilitiates tax advantages.
- Law mandating humane transport of horses through New York State.
- New York 100 Mile Competitive Trail Ride.
- Improvement and expansion of the New York Trail System.
- Inherent risk legislation.
- Law limiting landowner liability for equestrian usage.
- Requirement for Equine Rabies Vaccination for State Fairground Events.
